- EEC shipment: EUR 100
- Outside EEC shipment (including United Kingdom): EUR 150

EMBRYO TRANSFER

In the case of the use of the embryo transfer technique, each additional foal will be invoiced for an amount equivalent to the price of one straw.

In case of success, the buyer must send, before October 1st, 2022, a summary of the pregnant mares signed by the veterinarian or the person in charge of the site performing the embryo transfers.

In the event of the resale of straws, the terms of this agreement shall continue to apply to the straws' new owner.

FRAUD
